Opening orders for approved accounts must be a minimum of \$500.00.

Payment Terms: New account terms are COD Cash / Money Order. Credit card payments also available, call for details.

Return Policy: We only accept defective returns within their East Coast USA Distributors warranty period; they will be exchanged for same model with pre-authorized RMA number. No returns for credit. Call for details.

Orders & shipping:

1. Truck delivery orders (where applies) will be charged \$5 for orders below \$500 and \$10 for orders below \$100. Call for further details.
2. UPS orders placed by 2:00 pm will ship out same day; orders placed after 2:00 pm will ship the following business day.
